The Asian Consortium on Human Rights-based Access to Justice (HRBA2J-Asia), established in October 2010, is a regional network for dynamic exchange of knowledge and practices on human rights-based access to justice among relevant civil society, academic and governmental institutions in Asia.

In partnership with United Nations-related agencies (particularly the UNDP-Asia Pacific and UN Democracy Fund) and other institutions, HRBA2J-Asia developed a resource material in 2011 entitled *A Manual on Human Rights-based Approach to Realizing Equal Access to Justice*, with translated versions in six languages in Southeast, Northeast and South Asia (Thai, Mandarin, Korean, Japanese, Urdu and Nepali) by 2013.

HRBA2J-Asia has member-organizations in three sub regions in Asia consisting of nongovernmental organizations, national human rights institutions, university-based centers and government offices.
